I hereby declared that the area covering startline and racetrack area are only for participant, pit crew, FMSCI Officials , VROOM Official team and Speedway Motor Sports official team and any unauthorised entry in the aforesaid area is strictly prohibited and the VROOM has every right to cancel my entry/ticket/pass/access of the event and VROOM can also initiate criminal proceedings for trespass and in the event any damage is cause initial proceedings for recovery of damages.

I also understand and confirm the onus of proving authenticity & legality of entry form, documents / vehicle papers submitted by me and the vehicle's legalities will be my responsibility. The organizers / promoters/ the event officials Etc. will not be liable or responsible for the same.

The Organizers and its affiliated parties will not be responsible for my/our health and the declared blood group in the forms is correct.

I assure the Organizers that the documents submitted by me are valid and I hereby indemnify the Organisers against any of the Claim/s in respect of any accident or otherwise.
